PURSUANT to the Sale and Supply of Alcohol Act 2012, **Karamsar Enterprises Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **5 Parkvale Road**, **Karori**, **Wellington**, and known as **Super Liquor Karori**, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

The licence is subject to the following conditions:

1. Subject to condition 3 alcohol may be sold on or delivered from the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday 9:00am to 11:00pm.

- 2. No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- 3. A remote sale of alcohol may be made at any time on any day. Any alcohol sold by remote sale must not be delivered at any time between 11.00pm and 6.00am the next day.
- 4. For any remote sale, the licensee must comply with the requirements in the Sale and Supply of Alcohol Regulations 2013 for signage and to ensure the purchaser is not a minor.
- 5. A one-way door restriction shall apply from 10.00pm. Patrons may not enter from this time; exit only.
- 6. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 7. The whole of the premises is designated **supervised**.
- 8. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 9. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 10. The Licensee must display signage as follows:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. For each principal entrance to the premises, a sign attached to the inside or outside of the premises, so as to be easily read by people immediately outside the premises, stating the ordinary hours of business during which the premises will be open for the sale and supply of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The premises are as set out on the plan submitted with the application and date stamped 12 May 2023 and each principal entrance is shown on that plan.


